Applicant Agreement

Applications are accepted on first come first paid basis beginning, August 1, 2025. Booth locations will be assigned when payment is received. No refunds will be issued after registration has closed at 5:00 p.m. on September 26, 2025. Applicants may only use the assigned booth location. Check in, set up and sales begin 7:00 a.m. on October 4, 2025.

The United Keetoowah Band is not responsible for accidents or injuries, or for any damage or theft on property belonging to the applicant.

1. Applicant agrees to not offer for sale any guns nor ammunition; nor any live animals; nor alcoholic drinks; nor illegal drugs or marijuana. Political booths are prohibited. All activities must comply with laws of the United Keetoowah Band.
2. Trailer/Smoker Units must reserve a minimum of 10x20 space. Absolutely no exceptions!
3. Vendors must supply their own 10 gauge power cord and sanitary water hose.
4. Applicants must furnish all equipment needed such as tables, chairs, and extension cords. Applicant agrees to remove all equipment, inventory, and personal property no later than 6:00 p.m. on October 4<sup>th</sup>, 2025.
5. Applicants must provide proof of tribal membership/citizenship in a federally recognized Indian tribe when any item is presented as an authentic American Indian product. In the event that the merchandise was created by someone other than the applicant, documented proof must be provided that the product(s) are authentic American Indian made product(s).
6. The applicant hereby consents to the jurisdiction of the United Keetoowah Band and any dispute related to this application shall be heard in the United Keetoowah Band Tribal Courts. The United Keetoowah Band does not waive its sovereign immunity.

I understand that failure to comply with any of the above-listed provisions will be considered breach of contract. Any monies received prior to breach of contract will not be refunded.
